Permenter Middle School Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

Permenter Middle School agrees to implement the following statutory requirements:

7. Permenter Middle School will provide assistance to parents, as appropriate, in understanding topics such as the State's academic content standards and student academic achievement standards, State and local academic assessments, how to monitor a child's progress, and how to work with educators to improve the achievement of their children. 8. Permenter Middle School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:




