To be classified in Groups A, B, or E, CHISD requires that 75% of the total participants of the activity or event be CHISD students. A roster may be required by the Assistant Superintendent of Operations.
A - CHISD-Affiliated, Non-Profit Groups (CHISD Support Organizations, Local Professional Organizations)
B1 - NonSchool Affiliated, Youth Oriented, Non-Profit Groups (Scouts, CH Youth Athletic Leagues); school days
B2 - NonSchool Affiliated, Youth Oriented, Non-Profit Groups (Scouts, CH Youth Athletic Leagues); nonschool days
C - Non-Youth Oriented & Non-School Affiliated, Youth Oriented Nonprofits (Churches, HOA & Non-Profit Adult Sports)
D - For Profit Groups (i.e. Dance Studios, Businesses, etc.)
E - For Profit, Full-Time CHISD Employees

IMPORTANT NOTES
Minimum 2 hour rental for all events.
There shall be an additional 1/2 hour rental fee added to all indoor events for pre-cooling and/or pre-heating of the rental space.
Each organization shall be charged an additional ½ hour for custodial set-up and a minimum of an additional hour for custodial clean-up.
Groups C & D shall pay a \$100 deposit for use of campus facilities, athletic fields & stadium, and Hawkins Hall; and a \$500 deposit for the PAC Auditorium.
Groups C & D shall be required to provide proof of insurance.
Use of other District facilities and their rates may be negotiated with the Assistant Superintendent of Operations.
