Lake Ridge Elementary School Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

Lake Ridge Elementary School agrees to implement the following statutory requirements:

6. **Lake Ridge Elementary School** will take the following actions to provide each parent **timely notice** when **their child** has been assigned or **has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified** within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- ✓ *Parent Conferences as needed*

7. **Lake Ridge Elementary School** will **provide assistance** to parents, as appropriate, in understanding topics such as the **State's academic content standards** and **student academic achievement standards, State and local academic assessments, how to monitor a child's progress**, and **how to work with educators** to improve the achievement of their children. 8. **Lake Ridge Elementary School** will **provide materials** and **training** to help **parents work with their children** to **improve** their children's **academic achievement**, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
